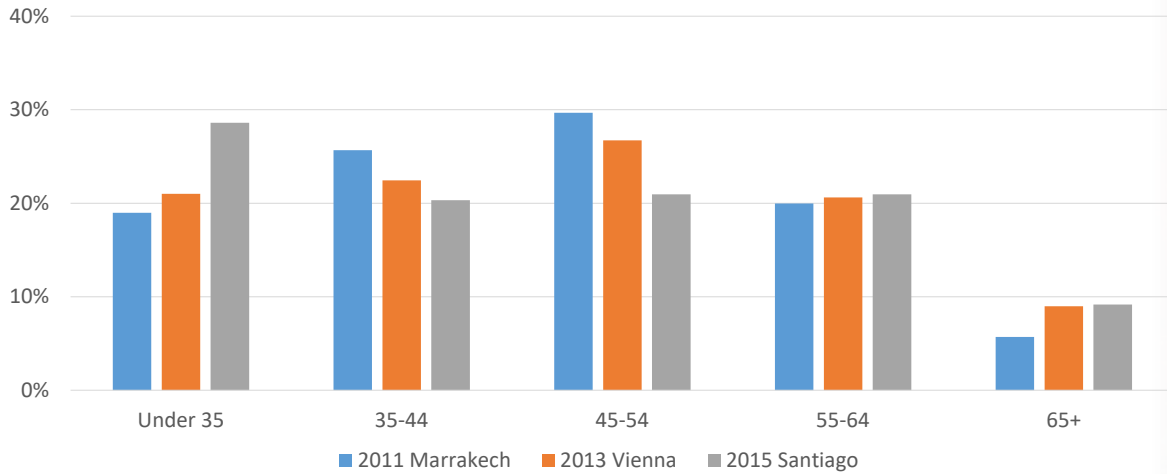

WCN 2011 in Marrakesh, 3,217 participants from 125 countries

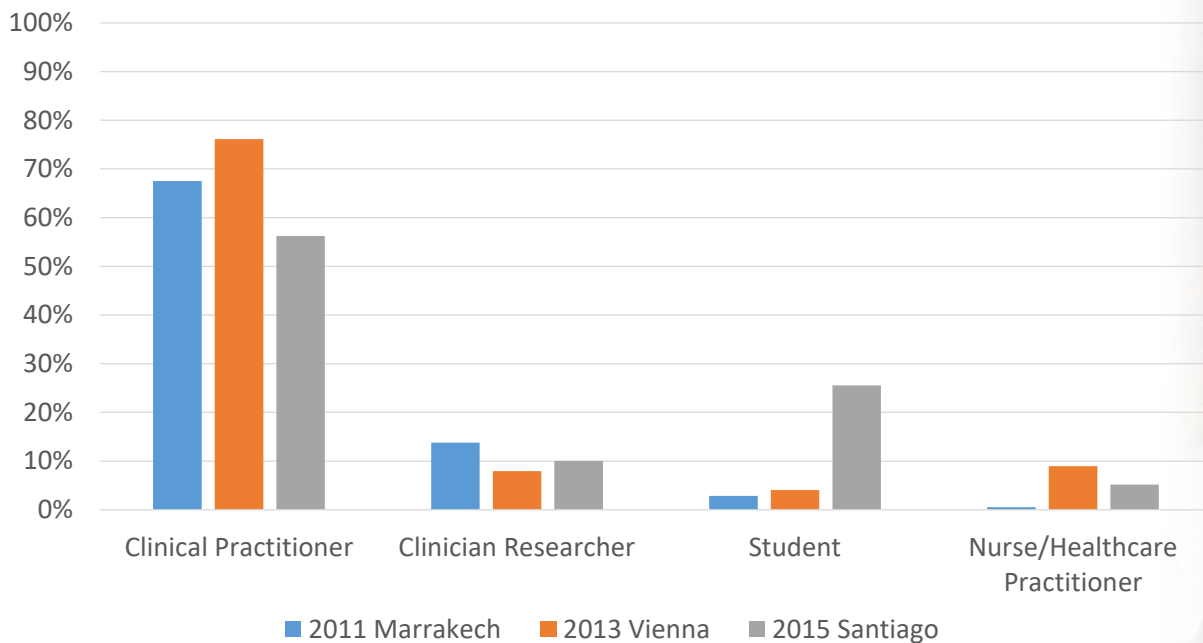
WCN 2013 in Vienna, 6,400 participants from 135 countries

WCN 2015 in Chile, 3479 participants from 109 countries

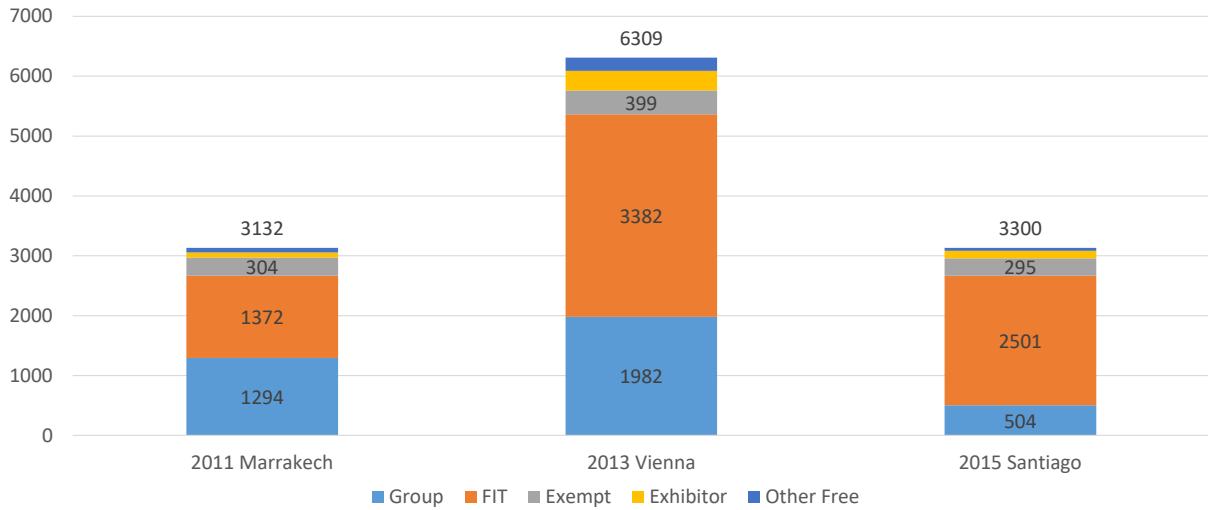
Participants by Age



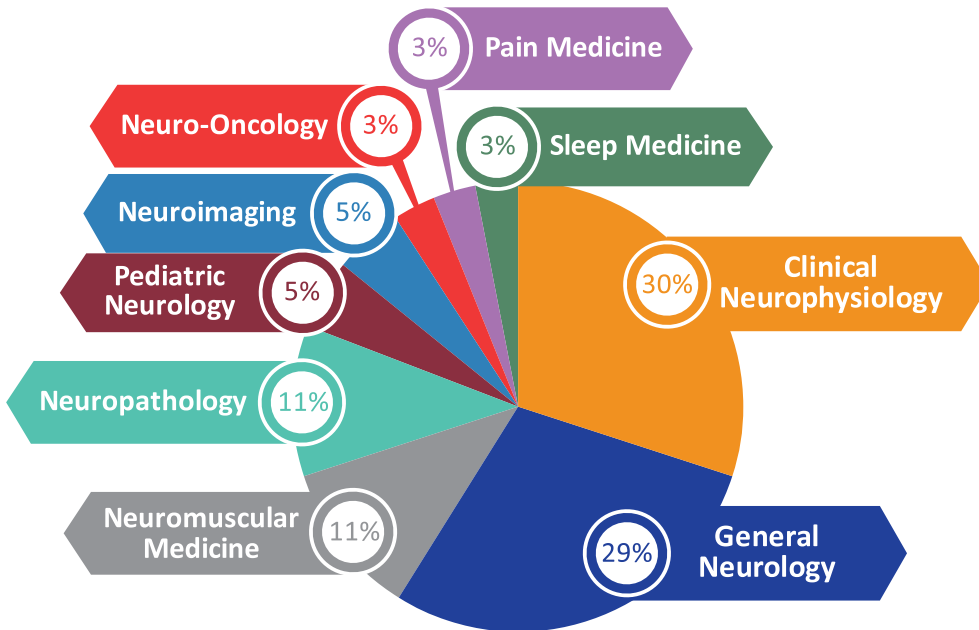
Professional Role



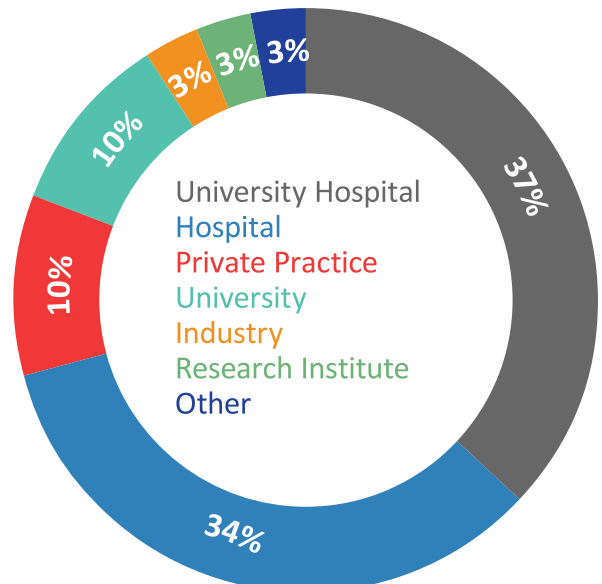
Registration Breakdown

INFORMATION ABOUT THE CONGRESS LOCATION AND VENUE

Kyoto, Japan has a population of 1.5 million. There are three airports near Kyoto. The Osaka International Airport is 50 minutes away by driving. The Kansai International Airport is 90 minutes away by a direct train. The Central Japan International Airport is less than 90 minutes by airport express.

The climate in Kyoto is humid subtropical, summer is hot and humid while winter is cold with occasional snow.

Visitors must obtain a visa. There are currently 67 countries / territories that are exempt from having to obtain a visa. 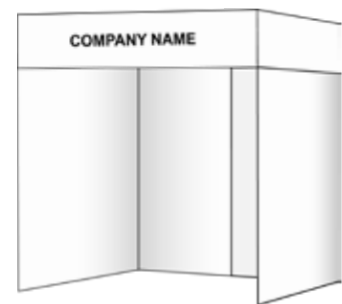

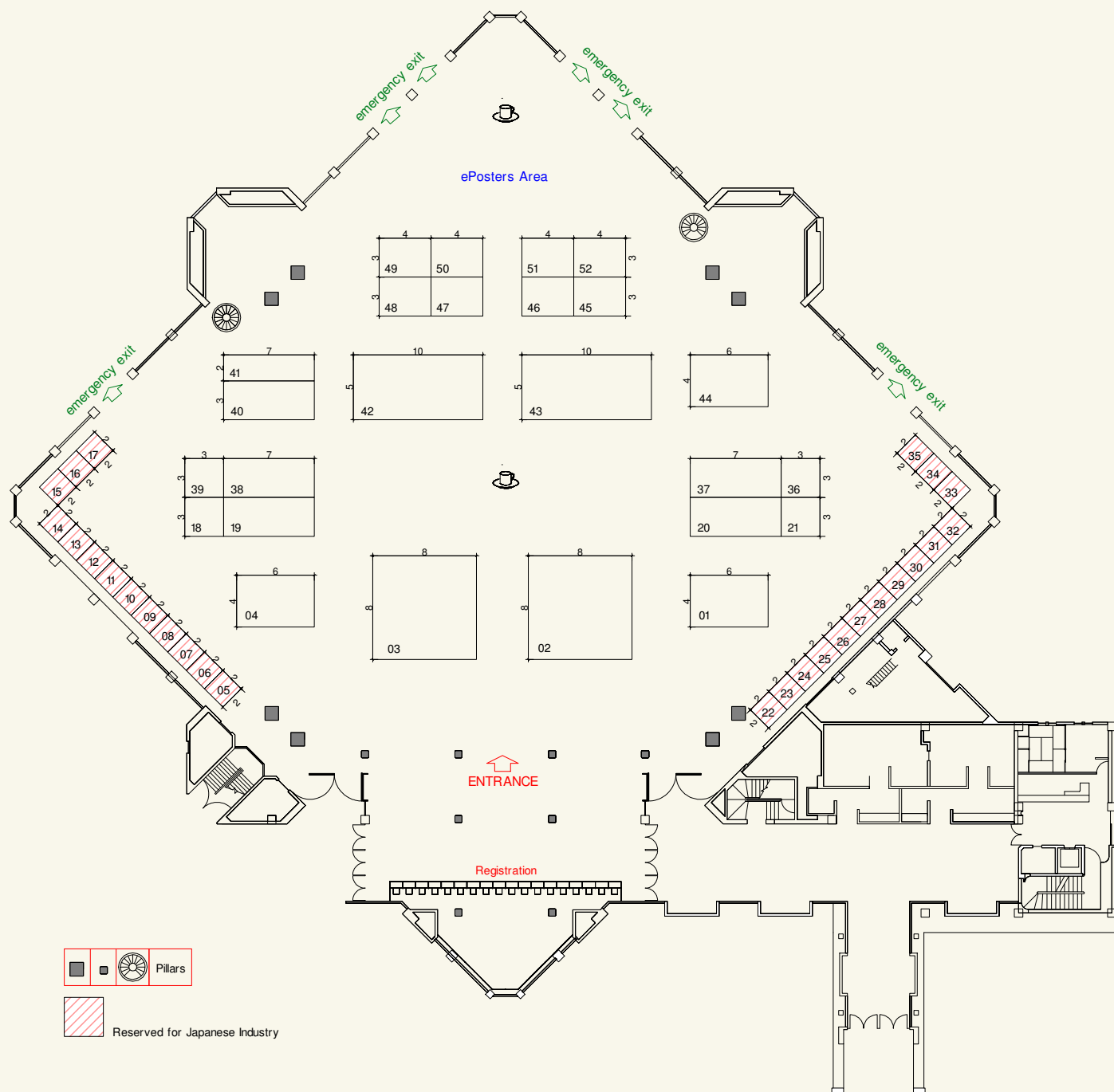
Shell Scheme stand sketch
